Description of PSSS Fee Structure

Fee	Amount	Description
Full Membership	\$350	All Privileges and obligations apply
Associate Membership	\$250	Clubhouse Privileges and banquet voucher
Crew Membership	\$50	Clubhouse Privileges / no banquet voucher
Dock Initiation Fee	\$200	Places member on seniority list. Associate or Full Member status must be maintained.
Option 1: Full Dock with Storage	(length + beam) x \$20	Includes dock, storage, lift in/out Full Members only
Option 2: Dockage No Storage	60% Option 1 Fee	Full Members only
Option 3: Winter Storage Only	40% Option 1 Fee	Full Members only
Option 4: Lift In OR Out	10% Option 1 Fee	Full / Associate Members only
Race Fees per season	\$125 if Prepaid	Prepayment Represents 50% saving. Races may be paid for individually.
Docking Levy Fee	\$400	Paid upon receipt of permanent dock
Off Site Cradle Storage	\$25	Full / Associate Members only
Facilities Key Fee	\$10	Refundable on resignation & key return
Work Hours Fee	\$250 (25 hours x \$10)	Full Members are required to work 25 hours annually in lieu of payment

1.03 Membership - Potential new members must first be sponsored by a member of the Squadron in good standing. [See Schedule H - Sponsor Responsibilities.] All new membership applications shall be approved by the Executive at a meeting attended by the sponsor within 30 days of receipt of application.

Membership in the Squadron shall consist of the following categories, and no person shall be refused membership on the grounds of race, ancestry, place of origin, colour, ethnic origin, citizenship, creed, sex, sexual orientation, age, same-sex partnership status, family status or handicap.

1.03.1 Full Member - A Full Member shall

- (a) be an owner or co-owner, lessee or co-lessee of a sailing vessel;
- (b) have paid the schedule of fees as set out in Section 3.06 and Schedule A- Membership Categories, Summary of Club Privileges, Obligations & Fees;
- (c) have full voting power at all meetings;
- (d) be eligible for election to the Executive;
- (e) have privileges/services as set out in Schedule 'A'- Summary of Privileges, Obligations and Fees; and
- (f) complete the requisite 25 work hours or make payment in lieu of as determined by the Executive. [See Schedule B - Work Hours Policy.]

1.03.2 Associate Member - An Associate Member shall:

- (a) have paid the schedule of fees as set out in Section 3.06 and Schedule A- Summary of Privileges, Obligations and Fees;
- (b) have voting power at all meetings except on financial matters;
- (c) be eligible for election to the Executive;
- (d) have privileges/services as set out in Schedule A- Membership Categories, Summary of Club Privileges, Obligations and Fees.
